Save your loved one's time and avoid probate through the court system by filing a simple deed on file with your property!

Even if you state where you would like your property to go upon your passing in a will, whomever it is receiving your property will have to file for a probate case through the court which can take up to six months to a year.

To avoid that timely wait, you can file what is called a 'transfer on death deed'.

A transfer on death deed allows you to select a beneficiary who will receive your property, but only once you've passed away. The beneficiary will have no right to your property while you are alive and, if you own your home jointly, the transfer on death deed does not apply until all of the owners have passed away.

You fill out this document, notarize it, and file it with a title agency in Alaska at any time for a small fee.
